June 17, 2025 REGULAR MEETING MINUTES

PRELIMINARY MATTERS

Call to Order

Chair Jerry Martin called the regular meeting to order at 5:04 p.m. All Board members were present.

Land and Labor Acknowledgements were read by Lisa Jameson

President's Update

Dr. Crawford's provided information on the federal landscape and the direct impact on students. She shared the budget proposes the elimination of funding for several vital programs, including: FSEOG, all seven TRIO Programs including Upward Bound, Student Support Services, and Veterans UB, which offer crucial support services. Others that are proposed to be eliminated include: GEAR UP, SIP, FIPSE, CCAMPIS, and Adult Basic Education. Proposed funding reductions are proposed for Maximum Pell Awards, eliminating subsidized federal student loans, and the federal workforce study program. She stated these cuts will impact our community and our college students and PELL alone could possibly impact 200 students at EvCC who won't be able to afford college. It's important to keep an eye on the federal landscape and state funding.

Dr. Crawford said that on a more positive and celebratory note, EvCC's commencement was a huge success. There were 3,329 guests, 450 graduates participated, 1,900 people watched the livestream, 65 faculty and staff participated, there were 37 faculty/staff who volunteered as event workers, as well as 15 student leaders. There were 1,792 credentials awarded. She thanked Jenn Rhodes, Brandon Dyer, and the rest of the commencement team for another well-planned event

Dr. Crawford recognized the baseball and softball teams for their outstanding record and success this year. Many of the players attended the meeting in person. And she honored EvCC's Athletic Director, Garet Studer. Garet was recently honored as the recipient of the 2025 NWAC Dutch Triebwasser Award. It is a highly prestigious award established in 1990 by the Northwest Athletic Conference (NWAC), which recognizes individuals who demonstrate outstanding leadership and meticulous attention to detail in their work with athletics and higher education. It is a testament to his significant accomplishments and leadership at EvCC and also throughout the Northwest Athletic Conference Region.

Garet Studer then shared with the board the amazing accomplishments of this year's baseball and softball teams. Baseball and softball both won North Region championships by finishing the regular season at the top of the North Region standings. For softball, it was the 3rd championship in five years and for baseball it was the 7th championship in the past 10 years. Both teams advanced to the NWAC Championship tournament They not only excel in their sports, but also academically. The softball team was awarded the Athletic Team of the Year at the Hall of Fame Banquet.

E. Reports from the Board

Trustee Joe M. Davis II said it is great to hear about students. This was his first year at EvCC's graduation and it was great to see everyone cross the stage and to hear families congratulating students. He had the opportunity to go to the ACT Conference to learn about the state of Washington Trustees and is happy to be

on the board. Dr. Betty Cobbs also attended the conference with Trustee Davis and Dr. Crawford. She said it's exciting to see trustees from all across the state. She said that every year the best event she gets to go to is graduation. It is such a joyous occasion and thanked everyone who made it great-supporting the success of our students and recognizing all that students do to keep going and succeed.
